## **A GUIDE FOR CONTRIBUTORS & READERS**

---

---

The Law Faculty of the University of Malaya welcomes original unpublished works on topics of legal interest in the form of articles, comments, case notes and book reviews to be published in the Journal of Malaysian and Comparative Law (JMCL). Submissions may be made throughout the year and selected works will be published annually, either in Part 1 or Part 2 of the relevant Volume. Information on the deadline for the Part 1 and Part 2 of the Journal can be found on the Law Faculty's website.

Each manuscript will be reviewed by the Editorial Board before approval for publication. Contributors will be notified of acceptance, rejection or the need for revision of their respective manuscripts. The editors retain the right to make stylistic and grammatical changes to manuscripts accepted for publication without necessarily informing the contributor.

### **PREPARATION OF MANUSCRIPTS**

- (1) Manuscripts should not have been published, submitted, or accepted for publication elsewhere. Only original contributions are considered for publication.
- (2) Manuscripts should be typed on A4 paper, double-spaced, with generous margins on all sides of the paper. A copy of the manuscript should be furnished and, wherever possible, accompanied by a soft copy of the manuscript (preferably in Microsoft Word format) in a diskette. For those who use e-mail, manuscripts may be sent via e-mail attachments.
- (3) Footnotes should be numbered sequentially from 1 to 99 and should appear at the foot of each page.

(4) Final responsibility for the accuracy of all citations and quotations rests with the contributors.

(5) Quotations of more than 30 words should be indented without quotation marks. Shorter quotations within the text should be enclosed by double inverted commas.

(6) The following should be in italics:

- (i) Case names except the letter "v"
- (ii) Latin and other foreign words;
- (iii) Abbreviations - eg, *ie*, *ibid*, *cf*.
- (iv) Titles of books and law journals/periodicals.

(7) References:

The full title, date and place of publication should be given at first mention, thereafter, *supra* should be used.

- (8) The title page should include the contributor's name in full designation, institutional affiliation, address for correspondence and/or e-mail.
- (9) Submissions must include a table of content followed by an abstract of not more than 250 words.
- (10) The above guidelines are not exhaustive. Contributors are kindly requested to refer to past issues of the JMCL for other style guides.
